APPLICATION CHECKLIST, PRELIMINARY APPLICATION FORM & STATUTORY DECLARATION

All retired practitioners (depending on the length of time away from active practice) are required to complete the following:

- a) Non-Active for the past 12 Months - complete the following list of requirements.
 - b) Non-Active for 13 - 60 Months - complete the following list of requirements and pass a practical examination administered by the ACO Registration Committee
 - c) Non-Active greater than 60 Months - complete the following list of requirements, successfully complete the Retired Practitioner Assessment protocol, practice under the supervision of another Regulated Member for a minimum of 6 months and satisfy any other requirement of the ACO Registration Committee.
1. **Letter of Good Standing** - Have the Registrar in all jurisdictions you have been licensed and/or practiced in forward a Letter of Good Standing directly to the Registrar of the Alberta College of Optometrists (ACO) stating that you are currently (or were upon leaving) a member in good standing. In addition, the letter must:
 - State whether you are currently under investigation or whether you have ever been found guilty of unprofessional conduct in the past.
 - Be dated within 30 days of processing your application.
 - State that you have maintained your Continuing Competence requirements such as continuing education credits, practice assessment and hours of active practice while practicing in that jurisdiction.
 2. **Additional Continuing Education Courses** – Please submit a listing of all continuing education courses you have taken since retirement (if any).
 3. **Labor Mobility** – The Canadian Free Trade Agreement (CFTA) became effective on July 1, 2017. This agreement allows for enhanced transfer of practitioners from one province to another. As a result, practitioners licensed in one province do not have to challenge the OEBC exam when moving to another province; however, applicants may have to demonstrate their competence through a practice assessment or quality assurance appraisal. Each application will be reviewed on its own merits. For further information, please contact the ACO office.
 4. **IOBP and Advanced Standing Program** - All graduates of non-ACOE accredited Schools of Optometry (those located outside of Canada or the United States) are required to:
 - a) Have their credentials assessed by FORAC. Complete credentialing information is available on the FORAC website: www.forac-faroc.ca.
 - b) Successfully complete the Advanced Standing Program (or previous IOBP) at the University of Waterloo. Complete course information is available at: <https://uwaterloo.ca/advanced-standing-optometry-preparatory-program/>
 5. **National Board Exam** – copy of your National Board Exam results.

6. **Preliminary Application Registration Fee** - The Alberta College of Optometrists (ACO) levies a Preliminary Application Registration Fee of \$400.00 (Canadian funds only). The ACO office accepts Visa, MasterCard, money orders, cheques or cash.
7. **Optometry Degree and/or Diploma** – Please forward a certified copy of your optometry Degree and/or Diploma. This certification must be notarized by a lawyer, public notary, Justice of the Peace, University official or Commissioner of Oaths.
8. **Certification** – The ACO requires that all new Regulated Members must be TPA certified and Advanced Scope certified (definitions on pages 6 & 7). A Practice Permit will not be issued unless the applicant is both TPA and Advanced Scope certified.
9. **Official Transcripts** - Please ensure that official copies of **all** of your post-secondary transcripts are forwarded to the ACO office. You may request that the University send your transcript(s) directly to the ACO office or have them sent to you. If the transcript(s) is sent directly to you, you must forward this documentation to the ACO office in its **original sealed envelope**. Opened or unsealed envelopes will not be accepted. Official transcripts include courses taken during your B.Sc., M.Sc., O.D., Ph.D. or other equivalent program(s).
10. **ACO Jurisprudence Exam** - The ACO Jurisprudence Exam is a one hour, closed book exam based on based on provincial legislation and the ACO Standards of Practice (available on the ACO website) and is structured in a true/false and multiple choice format. The exam can be written:
 - a) At the Alberta College of Optometrists office in Edmonton; or,
 - b) At an office in Calgary.
 Please contact the Alberta College of Optometrists office for registration and additional information about this process.
11. **CPR Certificate** - All applications must include a current Basic Life Support Cardiopulmonary Resuscitation (CPR) Certificate. CPR certificates are available from a variety of providers such as Red Cross, Heart & Stroke Foundation, YMCA, St. John’s Ambulance, etc.
12. **Criminal Records Check** - The ACO requires a Criminal Records Synopsis that includes a Vulnerable Sector Search for all new applicants. The fee for obtaining this document from the Royal Canadian Mounted Police (RCMP) or local Police Detachment is the responsibility of the applicant. In addition, the document must be **submitted directly to the ACO office**. Please visit www.rcmp-grc.gc.ca for further information on this requirement.

- c) Completing a separate TPA Certification Course (minimum of 100 hours long of which 60 hours are didactic and 40 hours are clinical) for practitioners who graduated before January 1, 1996.
- d) Completing appropriate therapeutic care clinical hours and patient experiences for graduates of non-accredited Schools of Optometry.

Advanced Scope certified is defined as:

- a) Graduating after January 1, 2015 and passing the entire OEBC or CACO exam.
- b) Graduating after January 1, 2012 and registering in another Canadian province with the NBEO and passing the Alberta Advanced Scope Certification Course final exam before transferring to Alberta.
- c) Graduating in 2012 to 2014 and passing the CACO exam; and, passing the Alberta Advanced Scope Certification Course final exam.
- d) Graduating in 2011 or earlier and passing the complete Alberta Advanced Scope Certification Course or equivalent.
- e) Being registered and certified in a jurisdiction with similar legislation and certification requirements and passing the Alberta Advanced Scope Certification Course final exam.
